Background Information

The Regional Research, Development, and Innovation Committee (RRDIC) of the Regional Development Council (RDC) Western Visayas acknowledges the critical importance of addressing significant challenges related to Smart Agriculture, Artificial Intelligence (AI), and the Blue Economy.
